ORDINANCE NO. 332

AN ORDINANCE AMENDING ORDINANCE NUMBERS 249, 296, AND 298 OF THE CITY OF FOREMAN, ARKANSAS; AND ANY OTHER ORDINANCES IN CONFLICT HEREWITH REGARDING THE COLLECTION OF GARBAGE AND TRASH; AND DECLARING AN EMERGENCY.

WHEREAS, it is the determination and finding of the City Council for the City of Foreman, Arkansas (the "City") that it would be in the best interest of the City and its citizens if the City engaged in and took on the task of providing garbage and trash collection for its citizens whether than to contract out for said services.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FOREMAN, ARKANSAS:

SECTION I: Section 1 of Ordinance 298 shall and hereby is deleted and removed.

SECTION 2: The City of Foreman shall from this date on be the exclusive and sole provider of the service of garbage and trash collection for its citizens, with the effective date of collection to commence on April 1, 2019. The collection rates and fees currently being charged to and paid by the citizens for trash and garbage collections now, shall remain the same in their current amounts.

<u>SECTION 3:</u> That no other party, person, entity and /or corporation shall engage in the business of collecting trash and garbage within the City of Foreman from this date without first obtaining the written permission from the City.

<u>SECTION 4:</u> That all ordinances and/or parts of ordinances in conflict with ordinance are hereby repealed.

<u>SECTION 5:</u> That the provisions of this Ordinance are severable and if a section, phase or provision shall be declared invalid; such declaration shall not affect the validity of the remainder of this Ordinance.

EMERGENCY CLAUSE: It is hereby determined by the City Council, City of Foreman, Arkansas that the immediate collection and disposal of garbage and trash provides a substantial health benefit to the citizens of Foreman, Arkansas and therefore an emergency exists and this Ordinance being necessary to preserve the health, safety, and peace of the citizens of the citizens of the City of Foreman, Arkansas shall be in full force and effect from and after its passage.
