

ORDINANCE NO. 325

AN ORDINANCE TO AMEND ORDINANCE NO. 76 TO REQUIRE ALL CITIZENS LIVING WITHIN THE CITY LIMITS OF FOREMAN, ARKANSAS TO CONNECT TO CITY WATER IN ADDITION TO CITY SEWER SYSTEM. ALL DWELLINGS, HOUSE TRAILERS, OR OTHER STRUCTURE OF WHATSOEVER KIND OF CHARACTER THAT IS LOCATED WITHIN THREE HUNDRED (300) FEET OF A MUNICIPAL WATER OR WASTEWATER MAIN.

WHEREAS, the City Council of the City of Foreman, Arkansas shall require that all dwellings, households, house trailers or other structure of living premises of whatever character to connect to city water that is located within three hundred (300) feet of a municipal water or wastewater main.;

WHEREAS, it shall be necessary for all dwellings, households, house trailers, and other inhabited structures to connect to city water for the health and safety of all citizens within the city limits of Foreman, Arkansas within three hundred (300) feet of a municipal water or wastewater main.

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Foreman, Arkansas:

SECTION 1: That it is hereby authorizing and directing all property owners, lease holders, renters, and all dwellings of all types to connect to the City of Foreman Water and Wastewater System in conformance with Section 19-4126 of the Revised Statutes of Arkansas.

SECTION 2: All property owners that are leasing, renting, or providing living quarters of dwellings of any character which must provide city water and sewer connections which must be available to any leases, renters, or inhabitants of any dwelling or household in the City of Foreman, Arkansas.


SECTION 3: If the owner of said property fails, neglects, or refuses to provide access to city water and sewer connections to the dwelling within a two (2) week period of inhabitants moving into said dwelling, the property owner may be fined and if the situation is creating a public hazard, further steps will be initiated for correcting the infraction at the discretion of the court.

SECTION 4: This section shall apply to house trailers only if occupied for ten (10) days or more consecutively.


SECTION 5: That this ordinance shall be in full force and effect after three readings after passage and approval and proper posting.
